## A. Amendment to Investment Valuation Policy and Procedure ("Valuation Policy") of Capitalmind Mutual Fund

Investors / Units holders of the schemes of Invesco Mutual Fund ('the Fund') are requested to note that the Valuation Policy of Capitalmind Mutual Fund is amended to incorporate the provisions of SEBI Circular No. SEBI/HO/IMD/IMD-I PoD-1/P/CIR/2024/163 dated November 26, 2024, w.r.t. valuation of repurchase (repo) transactions by Mutual Funds. The above change is reflected at Clause 14.2.3 of Annexure I of the Valuation policy.

Further, changes were made to the clauses 14.1.6 (A), 14.1.6 (B), 14.1.7, 14.1.12, 14.1.14 (A), 14.2.5 (b), 14.4.2 (c), 14.5.1, 14.5.2 and Annexure 5A of the Valuation Policy. Accordingly, the Valuation Policy forming part of the Statement of Additional Information ("SAI") stands amended to that effect.
